DEFINITION

In this Release Agreement, the term "Ski & Snowboard Activities" shall include, without limitation participation in all forms of skiing, snowblading, all forms of snowboarding, telemark skiing, cross-country-skiing, all forms of snow skating, ski biking, use of non-traditional alpine equipment, ski jumping and use of any ski runs, trails, terrain parks, half-pipes, and race courses; use of all tickets and passes issued by the Releasees; and participation in all lessons, programs, camps, training, activities, events, leagues, races, or services related thereto and provided, arranged, organized, conducted, sponsored, hosted, or authorized by the Releasees and shall include, without limitation, snow school lessons, camps, programming, competitions, training, demonstrations, orientational or instructional courses, clinics, seminars and sessions; loading, unloading and travel by or movement in or around lifts, conveyors, snowcats, sleds, snowmobiles and motorized vehicles; use of or presence at restaurants, day lodges, parking, access roads and other facilities or areas; first aid and rescue services; and all other activities, events and services in any way connected with or related to the Releasees.

ASSUMPTION OF RISKS

I am aware that participating in Ski & Snowboard Activities will expose me to many risks, dangers and hazards that may result in physical injury, psychological injury, paralysis, brain injury, death, property damage or loss, including loss to other third parties. These risks, dangers and hazards include, without limitation: boarding, riding and disembarking ski lifts and conveyors; misloads or falls from ski lifts and conveyors; changing weather conditions; avalanches; exposed rock, earth, ice and other natural objects; trees, tree wells, tree stumps and forest deadfall; snow immersion; the condition of snow or ice on or beneath the surface; changes or variations in the terrain which may create blind spots or areas of reduced visibility; changes or variations in the surface or sub-surface, including changes due to man-made or artificial snow; variable and difficult conditions; streams, creeks and exposed holes in the snow pack above streams or creeks; cliffs; crevasses; snowcat roads, road banks or cut banks; collision with lift towers, fences, snowmaking equipment, snow grooming equipment, snowcats, snowmobiles or other vehicles, equipment or structures; use of halfpipes, terrain parks, rails, boxes, jumps and other features; reduced visibility caused by weather; collision with or being hit by other skiers or snowboarders, or other persons; loss of balance or control; slips, trips, and falls; accidents during snow school lessons; improper training techniques; failure to act safely or within one's own ability or to stay within designated areas; icy conditions; high impact falls or landings; speed misjudgment; underestimation of feature or run difficulty; improper body positioning on landing; fatigue; the negligence, inattention or inexperience of other persons; lack of fitness or conditioning; a medical condition whether known or unknown; negligent first aid; encounters with domestic or wild animals; infectious disease contracted through viruses, bacteria, parasites, and fungi which may be transmitted through direct or indirect contact; witnessing or being involved in a traumatic or upsetting event; and NEGLIGENCE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES INCOMPLETE OR IMPROPER INSTRUCTIONS AND FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM, OR WARN ME OF, THE RISKS, DANGERS AND HAZARDS OF PARTICIPATING IN SKI & SNOWBOARD ACTIVITIES. - **Alpine Responsibility Code:** I agree that I will comply with the Alpine Responsibility Code and other signage as posted at Castle Mountain and, if I am signing this Release Agreement as a parent/legal guardian, I agree it is my responsibility to ensure the minor understands and complies with the Alpine Responsibility Code.

 6. If this Release Agreement is completed electronically, I consent to signing this Release Agreement electronically and confirm that my electronic signature is the legal equivalent of my manual signature in this Release Agreement; and

If any provision of this Release Agreement is held by a Court to be unenforceable, then such provision will be modified to the minimum extent necessary to make it enforceable while reflecting the Participant and Releasees’ intention as closely as possible. All remaining provisions of this Release Agreement shall remain in full force and effect as drafted.

In entering into this Release Agreement, I am not relying upon any oral or written representations or statements made by the Releasees with respect to the safety of Ski & Snowboard Activities other than what is set forth in this Release Agreement.

I understand that any pass or ticket issued to me is the property of Castle Mountain, it is not transferable, may not be resold or used by others, and is revocable for misconduct or breach of Castle Mountain’s posted rules, including, without limitation, the Alpine Responsibility Code.

I CONFIRM THAT I HAVE READ AND I AGREE TO THIS RELEASE AGREEMENT.
